ORDINANCE NO. 069-2015

RENTAL CHARGES FOR THE TRAINING/WORKSHOP AREA AND ROOM ACCOMMODATIONS AT THE FORMER ORT TRAINING AND DEVELOPMENT CENTER BUILDING NOW HEREIN RENAMED AS LA UNION TECHNOLOGY LIVELIHOOD AND DEVELOPMENT CENTER (LUTLDC)

WHEREAS, the Sangguniang Panlalawigan, under Section 468 (2) (ii) of the Local Government Code of 1991, has the power to enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or reliefs;

WHEREAS, the Provincial Government of La Union has already acquired ownership of the former ORT Development Center Building located at Guerrero Road, City of San Fernando, La Union, with a training center area that can accommodate participants from various agencies interested to conduct seminars and trainings;

WHEREAS, in order to increase the provincial revenue, charges shall be imposed for the use of the training center area(s) and room accommodation;

WHEREAS, the necessary rates of rental charges were based on the studies and recommendations of the financial advisers of the Provincial Government of La Union;

NOW, THEREFORE, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. **Rental Charges.** Rental charges shall be imposed on any person who shall use the training center area and the rooms of the ORT Development Center Building, now hereinafter shall be renamed as the La Union Technology and Livelihood Development Center (LUTLDC), as follows:

RATES

CONFERENCE HALLS:

- AREA 1-2/1-3 P4,000 per 8 hours
P400/hour extension after the first 8 hrs.
P2,000 per 4 hours
P500/hour extension after the first 4 hours.
- AREA I or 2 P2,500 per 8 hours with 250/hour extension
P1,500.00 per 4 hours with 250/hour of extension

Section 2. **Implementing Guidelines.** Subject to the recommendation of the Provincial Treasurer, the Governor may formulate policies or guidelines relative to the operation and maintenance of the LUTLDC.

Section 3. **Duty of the Provincial Treasurer.** The Provincial Treasurer of the Provincial Government of La Union is hereby mandated to perform tax collection efforts pursuant to Section 470 (b) and (d) of R.A. No. 7160 otherwise known as the Local Government Code of the Philippines of 1991.

Section 4. **Repealing Clause.** Ordinances, proclamations, executive orders or administrative regulations, or a part or parts thereof, which are inconsistent with any of the provisions of this ordinance, are hereby repealed or modified accordingly.

Section 5. **Separability Clause.** If any portion or provision of this Act is declared void or unconstitutional, the remaining portions or provisions thereof shall not be affected by such declaration.

Section 6. **Effectivity.** This ordinance shall take effect in accordance with the applicable provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991.
