ORDINANCE NO. 043-2013

AMENDING SECTION 4 AND THE INCLUSION OF A NEW SECTION ON APPROPRIATIONS OF ORDINANCE NO. 036 – 2012 ENTITLED: "AN ORDINANCE CREATING THE LA UNION HUMAN IMMUNODEFICIENCY VIRUS/ACQUIRED IMMUNE DEFICIENCY SYNDROME (HIV/AIDS) COUNCIL"

EXPLANATORY NOTE

WHEREAS, the Honorable Governor has requested this Honorable Body through a letter dated June 10, 2013, to enact a resolution creating the Provincial AIDS Council of La Union;

WHEREAS, on December 6, 2012, the Sangguniang Panlalawigan had already enacted Ordinance No. 36-2012 Creating the La Union Human Immunodeficiency Virus/Acquired Immune Deficiency Syndrome (HIV/AIDS) Council, thus, the Sangguniang Panlalawigan deems it necessary to just amend said ordinance instead of a resolution;

WHEREAS, the amendment is to be made to attune to the present situation of the Province, and as an action of the August Body to the request of the Honorable Governor;

Be it enacted by the Sangguniang Panlalawigan in session duly assembled, that:

Section 1. This Ordinance shall be known and cited as an "Ordinance Amending Section 4 and the inclusion of a new section on appropriations of Ordinance No. 036 – 2012 entitled: "An Ordinance Creating the La Union Human Immunodeficiency Virus/Acquired Immune Deficiency Syndrome (HIV/AIDS) Council".

Section 2. Composition. The La Union HIV/AIDS Council shall be composed of the following:



- Chairman : Provincial Governor
- Vice-Chairman : SP Chairman, Committee on Health, Sanitation and Population Control
- Executive Officer : Provincial Health Officer II
- Members : SP Chairman, Committee on Peace and Order and Public Safety
 Representative, Provincial Health Office
 Representative, Provincial Health Team Office
 Representative, DILG Provincial Office
 Representative, Provincial Social Welfare & Development
 Superintendent/Representative, Department of Education, La Union Division
 Representative, Organization of People Living with HIV/AIDS
 Chief Executive Officer, La Union Medical Center
 Representative, DOH CCHD I
 Representative, ITRMC
 Representative, Faith based Organization
 Representative, Hotels, Resorts & Restaurants Association
 Representative, Philippine National Police
 Representative, Commission on Higher Education
 Representative, La Union Medical Society
 Representative, San Fernando City Health Office (*Represented because of its established STD Clinic*)
 Representative, Bauang Municipal Health Office (*Represented because of its established STD Clinic*)
 Representative/President, Greater Poro Entertainment Houses Association, City of San Fernando, La Union.

Section 3. Appropriation. The amount of P 100,000.00 is hereby appropriated from the General Fund of the Province of La Union for CY 2013, or any funds, available in the Provincial Treasury, not otherwise appropriated, for the implementation of this ordinance. Subsequent appropriation shall be provided by the Sangguniang Panlalawigan in the annual budget of the Province of La Union.


Section 4. Separability Clause. If, for any reason, any section or provision of this ordinance is declared unconstitutional, or inconsistent with any national law, other sections or provisions thereof, which are not affected thereby, shall continue to be in full force and effect.

Section 5. Repealing Clause. All ordinances, resolutions, rules and regulations, or parts thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

Section 6. Effectivity. This Ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.


