**GRANTING PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) TO ALL PROVINCIAL GOVERNMENT OF LA UNION (PGLU) OFFICIALS AND EMPLOYEES FOR CY 2013 CHARGEABLE AGAINST APPROPRIATION SAVINGS OF THE PROVINCIAL GOVERNMENT DURING CY 2013 PURSUANT TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) BUDGET CIRCULAR NO. 2013-3, DATED NOVEMBER 21, 2013**

WHEREAS, the Honorable Governor, in his urgent letter dated December 18, 2013, is requesting this Body to enact an Ordinance granting Productivity Enhancement Incentive to all PGLU officials and employees for CY 2013 chargeable against appropriation savings of the Provincial Government during CY 2013 pursuant to Department of Budget and Management (DBM) Budget Circular No. 2013-3, dated November 21, 2013;

WHEREAS, in the spirit of the season and in recognition of the cooperation and support of the entire Provincial Government of La Union (PGLU) Family in the development efforts of the present provincial administration, this Body therefore unanimously approves the granting of such Productivity Enhancement Incentive;

NOW, THEREFORE, on motion of Hon. Francisco "Kit" C. Ortega, Jr., jointly seconded by Hon. Robert B. Madarang, Jr. and Hon. Reynaldo M. Mosuela;

Be it enacted by the Sangguniang Panlalawigan in session duly assembled:

**Section 1. Appropriation Savings.** The granting of the Productivity Enhancement Incentive (PEI) to all Provincial Government of La Union (PGLU) Officials and Employees for CY 2013 is hereby appropriated, chargeable against appropriation savings of the Provincial Government during CY 2013 pursuant to the Department of Budget and Management (DBM) Budget Circular No. 2013-3, dated November 21, 2013.

**Section 2. Separability Clause.** If any provision of this ordinance shall be declared invalid or unconstitutional by a competent authority, the unaffected provisions shall remain in force and effect.


**Section 3. Repealing Clause.** All ordinances, resolutions, orders, circulars, memoranda and other issuances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.

**Section 4. Effectivity.** This ordinance shall take effect upon its approval.


