CONVALIDATING SP RESOLUTION NUMBERS 069-2009; 163-2009; 073-2010; 109-2010; 090-2011; 130-2012 AND 139-2012 AS AN ORDINANCE REALIGNING THE TOTAL AMOUNT OF PHP18,500,000.00 AS SAVINGS FROM THE PEACE AND ORDER INITIATIVE FUND OF THE PROVINCE FOR THE YEARS 2009, 2010, 2011 AND 2012 TO INTELLIGENCE AND CONFIDENTIAL FUND

WHEREAS, presented before this Body is an urgent letter of Gov. Manuel C. Ortega requesting the enactment of an Ordinance to convalidate SP Resolution Numbers 069-2009; 163-2009; 073-2010; 109-2010; 090-2011; 130-2012 and 139-2012 as an ordinance realigning the total amount of Php18,500,000.00 as savings from the Peace and Order Initiative Fund for the years 2009, 2010, 2011 and 2012 to Intelligence and Confidential Fund;

Section 1. Convalidate. SP Resolution Numbers 069-2009; 163-2009; 073-2010; 109-2010; 090-2011; 130-2012 and 139-2012 are hereby convalidated as an ordinance realigning the total amount of Php18,500,000.00 as savings from the Peace and Order Initiative Fund for the years 2009, 2010, 2011 and 2012 to Intelligence and Confidential Fund.

Section 2. Separability Clause. If any provision of this ordinance be declared invalid or unconstitutional by a competent authority, the unaffected provisions shall remain in force and effect.

Section 3. Repealing Clause. All ordinances, resolutions, orders, circulars, memoranda and other issuances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.

Section 4. Effectivity. This ordinance shall take effect upon its approval.
