## ORDINANCE NO. 038-2013

REALIGNING THE CY 2012 YEAR-END REMAINING BALANCES OF THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF ALL PGLU DEPARTMENTS/OFFICES TO THE OFFICE OF THE GOVERNOR (OPG) TO COVER THE NECESSARY EXPENSES OF THE SAID OFFICE DURING THIS PERIOD

WHEREAS, presented before this August Body for its consideration is an urgent letter of Gov. Manuel C. Ortega respectfully requesting the enactment of an Ordinance for the realignment of the CY 2012 year-end remaining balances of the Maintenance and Other Operating Expenditures (MOOE) of all PGLU departments/offices to the Office of the Governor (OPG) to cover the necessary expenses of the said office during said period;

WHEREAS, after finding the request of the Honorable Governor to be meritorious, the Sangguniang Panlalawigan deems it necessary to approve the passage of said ordinance which is intended to cover the necessary expenses of the Office of the Governor for CY 2012;

NOW, THEREFORE, on motion of Hon. Francisco "Kit" C. Ortega, Jr., jointly seconded by Hon. Rolando V. Rivera, Hon. Robert B. Madarang, Jr., Hon. Reynaldo M. Mosuela and Hon. Alfredo Pablo R. Ortega:

BE IT ENACTED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED, THAT:

Section 1. Realignment. The CY 2012 year-end remaining balances of the MOOE of all PGLU departments/offices are hereby realigned to the Office of the Governor (OPG) to cover the necessary expenses of the said office during said period.

Section 2. Separability Clause. If any provision of this ordinance shall be declared invalid or unconstitutional by a competent authority, the unaffected provisions shall remain in force and effect.

Section 3. Repealing Clause. All ordinances, resolutions, orders, circulars, memoranda and other issuances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.
