ORDINANCE NO. 040-2013

INCREASING THE BED CAPACITY OF BACNOTAN DISTRICT HOSPITAL IN BACNOTAN, LA UNION FROM TWENTY FIVE (25) TO FIFTY (50), UPGRADING ITS SERVICES AND FACILITIES AND PROFESSIONAL HEALTH CARE SERVICES, AUTHORIZING THE INCREASE OF ITS MEDICAL PERSONNEL AND APPROPRIATING FUNDS THEREFORE

Be it Enacted by the Sangguniang Panlalawigan of La Union in Session Duly Assembled:

SECTION 1. BED CAPACITY. The authorized bed capacity of the Bacnotan District Hospital in Bacnotan, La Union is hereby upgraded from Twenty Five (25) to Fifty (50) beds.

SECTION 2. FACILITIES/SERVICES. The existing service facilities and professional health care services of the Bacnotan District Hospital are hereby upgraded to conform with, and be commensurate to the bed capacity increase as provided for in Section 1 hereof.

SECTION 3. HUMAN RESOURCES. The existing workforce of the Bacnotan District Hospital shall also be correspondingly and gradually increased. The Provincial Health Office, Provincial Planning and Development Office, and the Provincial Budget Office in coordination with the Bacnotan District Hospital, Department of Health (DOH), Department of Budget and Management (DBM), the Civil Service Commission (CSC) and the Human Resource Management Division, shall determine the additional plantilla positions to be created and filled-up upon prior consultation with the Committee on Finance, Budget and Appropriations of the Sangguniang Panlalawigan of La Union and Office of the Governor.

SECTION 4. IMPLEMENTATION. The increase in bed capacity of the Bacnotan District Hospital from Twenty Five (25) to Fifty (50) beds shall be implemented for a period of not more than three (3) years from the approval of this Ordinance.

SECTION 5. FUNDING SOURCE. The Chief of Hospital of the Bacnotan District Hospital shall immediately include in the hospital's plan/program and budget the implementation

of this Ordinance, the funding of which shall be included in the Hospital and Province's Annual Performance Budget and Appropriations, as the case maybe.


SECTION 6. SEPARABILITY CLAUSE. If any provision of this ordinance shall be declared invalid or unconstitutional by a competent authority, the unaffected provisions shall remain in force and effect.

SECTION 7. REPEALING CLAUSE. All ordinances, resolutions, orders, circulars, memoranda and other issuances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.


SECTION 8. EFFECTIVITY. This Ordinance shall take effect fifteen (15) days after its complete publication in at least two (2) newspapers of local general circulation.
