EXECUTIVE ORDER NO. 25 Series of 2020

CREATING NEW GUIDELINES AND REGULATIONS IN THE OPERATION OF AGOO HYPERMARKET, REPEALING EXECUTIVE ORDER NO. 24A-2020.

WHEREAS, the presence of one (1) positive case of Coronavirus Disease 2019 COVID-19) in the Province of Pangasinan and two (2) COVID-19 cases in Province of La Union at which the latter cases are from the nearby Municipality of Caba prompted the LGU to put Agoo into an Extreme Enhanced Community Quarantine thru Executive Order No. 24-2020;

WHEREAS, one way to implement social distancing is to limit the number of consumers/customers entering the Agoo Hypermarket, thus, a scheme wherein clustered barangays were scheduled on a particular day was created;

WHEREAS, the first scheme scheduling seven (7) barangays per day was effective as to the observance of social distancing, however, the hypermarket can accommodate double the number of consumers/customers without compromising the prescribed social distancing measures;

WHEREAS, in order to resolve the concern of Agoeños who financially do not have the means to purchase and stock food items for a whole week at a time, and to give ample time for sanitization measures, there is a need to modify the existing guidelines on the operation of the Agoo Hypermarket;

THEREFORE, in view of the foregoing, I, STEFANIE ANN Y. ERIGUEL, M.D., Municipal Mayor of the Municipality of Agoo, La Union, by virtue of the powers vested in me by law, do hereby order:

Section 1. NEW GUIDELINES AND REGULATIONS IN THE OPERATION OF AGOO HYPERMARKET EFFECTIVE MARCH 28, 2020:

- 1. All meat/fish vendors may enter the hypermarket starting at 4:00 AM to prepare their products for merchandise. Only fish/meat stall owners/proprietors, helpers and slicers are allowed inside during this time.
- 2. Vegetable traders, and vegetable, rice, dried fish/condiments, pharmacy/drugstore, grocery stall owners/proprietors as well as their helpers may enter the hypermarket at 6:30 AM. No selling of merchandise will be allowed from 4:00 6:30 AM.
- 3. Hypermarket is open to consumers/customers at 7:00 AM to 5:00 PM.
- 4. The modified barangay schedule is as follows:

- 5. Agoo Hypermarket will be closed on Mondays for thorough disinfection and sanitization.
- 6. Entrance of consumers/customers shall be at the western main gate of the hypermarket. For comfort and convenience reasons, consumer/customer shall fall in line at the holding area located in the Hypermarket Basement Parking to P. Boado St.
- 7. A seat is allotted per consumer/customer such that social distancing will be observed. Sanitization of seats shall be done between batches of consumers.
- 8. To enter the hypermarket, every consumer/customer shall present a valid home quarantine pass and a valid ID to the market personnel on duty.
- 9. Standard sanitation procedures and wearing of masks prior to entry shall strictly be enforced.
- 10. Only fifty (50) persons are allowed to enter the hypermarket at a time, and will be given fifteen (15) minutes to purchase all necessities. A single whistle will signal customers/consumers that they have 5 minutes to complete purchases before being asked to leave. Two (2) whistles will signify that their marketing time is over and a new batch of consumers/customers will be allowed to enter.
- 11. Exit of consumers/customers shall be at the eastern main gate of the hypermarket.
- 12. A complete list of goods and necessities to be bought should be prepared beforehand to limit the time within the market premises.

Section 2. **REPEALING CLAUSE.** Previous issuance or any portion thereof, which are inconsistent with the provision of this Executive Order are hereby amended, modified, superseded or repealed accordingly.

Section 3. **SEPARABILITY CLAUSE.** If any section or provision of this Executive Order is declared void, ineffective or invalid by a court of competent jurisdiction, the holding of such section or provision to be void or invalid for any cause whatsoever shall in no way affect the validity of the remaining sections and provisions, which shall remain in full force and effect.

Section 4. **EFFECTIVITY CLAUSE.** This Executive Order shall take effect immediately upon the date hereof and shall remain in effect until rescinded, repealed or amended.
