

#### **EXECUTIVE ORDER NO. 25, SERIES OF 2020**

# EXTENDING THE IMPLEMENTATION OF AN ENHANCED COMMUNITY QUARANTINE (ECQ) IN THE MUNICIPALITY OF CABA, LA UNION UNTIL JULY 27, 2020

**WHEREAS**, last July 20, 2020, through Executive Order No. 23, Series of 2020, and with the concurrence of the Regional Inter-Agency Task Force (RIATF) against CoViD-19, the Municipality of Caba was placed under ECQ until July 25, 2020;

WHEREAS, as of yesterday, July 24, 2020, the Municipality recorded two (2) new positive cases, making necessary the proper surveillance, testing and quarantine interventions to be conducted and completed in accordance with the Operational Guidelines on the Application of the Zoning Containment Strategy in the Localization of the National Action Plan Against CoViD-19 Response;

**WHEREAS**, the undersigned is authorized, pursuant to Presidential Executive Order No. 112, Series of 2020, to impose, lift, or extend community quarantine in component municipalities subject to the concurrence of the RIATF;

**WHEREAS**, to allow sufficient time for the completion of necessary interventions and to prevent the further spread of the virus, and with the concurrence of the Honorable Mayor of Caba, the undersigned requested the RIATF for the extension of ECQ in the Municipality of Caba until midnight of July 27, 2020;

**WHEREAS**, the RIATF has interposed no objections to the requested extension;

NOW, THEREFORE, I, FRANCISCO EMMANUEL "PACOY" R. ORTEGA III, Governor of the Province of La Union, by the powers vested in me by law, do hereby order the extension of the implementation of Enhanced Community Quarantine (ECQ) until midnight of July 27, 2020 in the Municipality of Caba, La Union.
