

EXECUTIVE ORDER NO. 19-C, SERIES OF 2020

AMENDING EXECUTIVE ORDER NO. 19, SERIES OF 2020, AS AMENDED, IN IMPLEMENTING MODIFIED GENERAL COMMUNITY QUARANTINE IN THE PROVINCE OF LA UNION

WHEREAS, on June 4, 2020, this Office issued Executive Order (EO) No. 19-A, series of 2020 based on the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) Resolution No. 43, Series of 2020, amending EO No. 19, series of 2020 dated May 4, 2020, which localized the Omnibus Guidelines for the implementation of Community Quarantine in the Philippines;

WHEREAS, the IATF issued Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with amendments as of July 16, 2020, amending some provisions of the Guidelines in the implementation of Community Quarantine in the Philippines; and

WHEREAS, there is a need to amend EO 19, Series of 2020, EO 19-A, and EO19-B Series of 2020, to strengthen border controls and to require stricter requirements for entry to the Province;

NOW, THEREFORE, I, FRANCISCO EMMANUEL "PACOY" R. ORTEGA III, Governor of the Province of La Union, by virtue of the powers vested in me by law, do hereby amend the following provisions of EO No. 19, Series of 2020:

<u>SECTION 1.</u> Section 9 (g) is hereby amended to include the following categories persons who will enter the Province of La Union during the implementation of MGCQ as follows:

- 1. Residents of La Union Returning from Official Business Outside of the Province:
- 2. Non-Residents of La Union with Official Business;
- 3. Non-Residents of La Union without Official Business:

- 4. Locally Stranded Individuals;
- 5. Returning Overseas Filipinos;
- 6. Tourists from Region I; and
- 7. Persons Passing through La Union on the Way to Ilocos Sur and Ilocos Norte.

For this purpose, the following documents shall be required from persons crossing zones for work permitted in the zone of destination, and going back home on Border Quarantine Control Points (QCPs):

- 1. RESIDENTS OF LA UNION RETURNING FROM OFFICIAL BUSINESS OUTSIDE THE PROVINCE
 - a. Outside of the Province for 1 Day
 - i. La Union Health Declaration Form
 - ii. Company ID or Certificate of Employment
 - iii. Proof of Local Address
 - iv. Travel Order/Mission Order from company/government agency or any related document with inclusive date of travel
 - b. Outside of the Province for 2-7 Days
 - i. La Union Health Declaration Form
 - ii. Company ID or Certificate of Employment
 - iii. Proof of Local Address
 - iv. Travel Order/Mission Order from company/government agency or any related document with inclusive date of travel
 - v. Local Health Unit-issued Health Certificate from the place of business transaction
 - c. Outside of the Province for More than 7 Days
 - i. La Union Health Declaration Form
 - ii. Company ID or Certificate of Employment
 - iii. Travel Order/Mission Order from company/government agency or any proof of official business with inclusive date of travel

- iv. Local Health Unit-issued Health Certificate from the place of business transaction (issued within 3 days before actual return to La Union)
- v. Negative RT-PCR results (issued within 3 days before the actual return to La Union). If none, the resident shall be confined at the LGU isolation facility for testing and isolation until the results of the test are released.

2. NON-RESIDENT OF LA UNION WITH OFFICIAL BUSINESS

a. Staying for 1 day in the Province

- i. La Union Health Declaration Form
- ii. Company ID or Certificate of Employment
- iii. Travel Order/Mission Order from company/government agency or any proof of official business with inclusive date of travel. In the case of delivery cargoes Delivery Manifests should be presented in border checkpoints.
- iv. Local Health Unit-issued Health Certificate from the place of origin (issued within 3 days before actual arrival in La Union)

b. Staying more than 1 day in the Province

- i. La Union Health Declaration Form
- ii. Company ID or Certificate of Employment
- iii. Travel Order/Mission Order from company/government agency or any proof of official business with inclusive date of travel. In the case of delivery cargoes Delivery Manifests should be presented in border checkpoints.
- iv. Local Health Unit-issued Health Certificate from the place of origin (issued within 3 days before actual arrival in La Union)
- v. Negative RT-PCR results (within 3 days before actual arrival in La Union). If none, the non-resident will not be allowed to enter the Province.
- vi. Booking Confirmation (if staying in a hotel)

3. NON-RESIDENTS OF LA UNION WITHOUT OFFICIAL BUSINESS

- a. <u>La Union Health Declaration Form</u>
- b. Identification Card (ID)
- c. Travel Authority from PNP
- d. <u>Local Health Unit-issued Health Certificate from the place of origin</u>
 (issued within 3 days before actual arrival in La Union)
- e. <u>Negative RT-PCR results (within 3 days before actual arrival in La Union)</u>. If none, the non-resident will not be allowed to enter the Province.
- 4. LOCALLY STRANDED INDIVIDUAL (LSI)
 - a. <u>La Union Health Declaration Form</u>
 - b. Identification Card (ID) with proof of local address
 - c. Travel Authority from PNP
 - d. <u>Local Health Unit-issued Health Certificate from the place of origin</u> (within 3 days before actual arrival in La Union)
 - e. <u>Negative RT-PCR results (within 3 days before actual arrival in La Union)</u>. If none, LSI shall be confined at the LGU isolation facility for testing and isolation until the results of the test are released.
 - f. If LSI is traveling with a hired vehicle, the driver must present:
 - i. Identification Card (ID)
 - ii. La Union Health Declaration Form
 - iii. LTFRB permit to operate during Covid-19 pandemic
 - iv. The driver should present PNP travel authority and health certificate of all passengers including the driver

- v. If the hired driver is from outside the province, the driver must surrender his driver's license to the PNP personnel in the border QCP
- vi. If hired driver is from the province and LSI does not have RT-PCR results, driver must be isolated in the LGU isolation facility for testing together with the LSI/s until the results of the test are released.

g. If LSI is traveling with private vehicle, driver must present:

- i. Identification Card (ID) for proof of kin with LSI/s
- ii. La Union Health Declaration Form
- iii. Single PNP Travel authority with name of driver and LSI/s;
- iv. Local Health Unit issued Health Certificate from the place of origin (within 3 days)
- v. If LSI does not have RT-PCR result, the driver must be isolated in the LGU isolation facility for testing together with the LSI/s until the results of the test are released.

5. RETURNING OVERSEAS FILIPINO

- a. Passport
- b. Bureau of Quarantine Certificate
- c. Negative RT-PCR results (issued within 3 days before actual arrival in La Union). If more than 3 days, ROF/OFW is considered LSI and shall present other necessary documents according to the preceding section. Rules on traveling with hired and private vehicles from the preceding section shall also be applied.
- d. <u>If ROF presented the BOQ Certificate of Recovery in lieu of Negative RT-PCR results, ROF must be isolated in the LGU isolation facility for testing.</u>

6. TOURISTS FROM REGION 1

Only tourists from provinces in Region 1 with the same risk classification as La Union or lower will be allowed to enter to the Province for purposes of leisure subject to the following requirements:

a. Day Tour

- i. La Union Health Declaration Form
- ii. Identification Card (ID) with Proof of Address
- iii. Travel Authority from PNP (if from outside La Union)
- iv. Local Health Unit-issued Health Certificate from place of origin (issued within 3 days before actual arrival in La Union)

b. More than 1 day

- i. La Union Health Declaration Form
- ii. Company ID or Certificate of Employment
- iii. Travel Authority from PNP (if from outside La Union)
- iv. Local Health Unit-issued Health Certificate from the place of origin (issued within 3 days before actual arrival in La Union)
- v. Negative RT-PCR results (within 3 days before actual arrival in La Union). If none, visiting tourist will not be allowed to enter the Province.
- vi. Booking Confirmation (if staying in hotel)

All tourists shall be required to pass through the established Tourist One Stop Shop (TOSS) established at the LGU of destination as provided in Executive Order No. 20-A, Series of 2020, the applicable provisions of which are hereunto made an integral part of this issuance.

7. PERSONS PASSING THROUGH LA UNION ON THE WAY TO ILOCOS SUR AND ILOCOS NORTE

- a. La Union Health Declaration Form
- b. Applicable Documents Required by the Province of Destination
- c. <u>Persons passing through La Union will be given, a maximum of three</u> (3) hours to cross border QCPs.

SECTION 2. Separability Clause. Other Sections of EO 19, Series of 2020, which are not hereby revoked, amended and modified accordingly, shall remain in effect.

SECTION 3. Reservation Clause. The guidelines contained herein shall be subject to amendments that may be issued by the National Government, the IATF-EID, and/or other concerned government agencies.

SECTION 4. Effectivity Clause. This Executive Order shall take effect immediately.
