**BAC Resolution No. 02E S. 2020** 

RESOLUTION RECOMMENDING THE APPROVAL AND ADOPTION OF SMALL VALUE PROCUREMENT (UNDER NEGOTIATED PROCUREMENT) AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PROVINCIAL GOVERNMENT OF LA UNION FOR THE PURCHASE OF CONSULTANCY SERVICES FOR THE USE OF THE OFFICE OF THE PROVINCIAL ADMINISTRATOR

WHEREAS, presented before this Body is the need for the purchase of consultancy services for the use of the Office of the Provincial Administrator amounting to FOUR HUNDRED FIFTY THOUSAND PESOS (P450,000.00);

**WHEREAS**, under Section 53.9 of Rule XVI of the 2016 Revised Implementing Rules and Regulations of RA 9184, the procuring entity may resort to Small Value Procurement, as an alternative mode of procurement, subject to approval of the head of the procuring entity and whenever justified by the conditions provided in the aforementioned law; and

WHEREAS, under the said Section, the Procuring Entity may resort to Small Value Procurement "where the procurement does not fall under Shopping of this IRR and the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR", provided, that the terms and conditions for the use of Alternative Methods of Procurement found in Section 54 of the 2016 Revised IRR shall be followed, if applicable.

**NOW**, **THEREFORE**, on motion duly seconded, be it:

**RESOLVE, as it is hereby RESOLVED**, to recommend Small Value Procurement (under Negotiated Procurement) pursuant to Section 53.9 of the 2016 Revised IRR as an alternative method of procurement for the purchase if consultancy services for the use of the Office of the Provincial Administrator under the Provincial Government of La Union;

Resolved, Further, that the BAC Secretariat is hereby directed to post an invitation or request for submission of price quotations/proposals in the PhilGeps website, the Provincial Government of La Union website, and at any conspicuous place reserved for this purpose in the Provincial Government of La Union premises for a period of at least (3) calendar days; and

**RESOLVED FINALLY**, to furnish a copy of the resolution to all persons and offices concerned for their guidance.
