EXECUTIVE ORDER NO. 52

Series of 2021

PLACING SOME PORTIONS OF TWENTY (20) BARANGAYS OF AGOO, LA UNION INTO A HEIGHTENED LOCALIZED ENHANCED COMMUNITY QUARANTINE (CRITICAL ZONE) DUE TO COVID-19 POSITIVE CASES.

WHEREAS, from March 31 to April 2, 2021, thirty six (36) new COVID-19 positive cases were recorded in various barangays of Agoo;

WHEREAS, prevalence of new cases is very alarming, thus, there is a need to institute precautionary/preventive measures in some portions of the affected barangays to prevent further spread of the virus in the community;

NOW THEREFORE, I, STEFANIE ANN Y. ERIGUEL, M.D., Municipal Mayor of the Municipality of Agoo, La Union, by virtue of the powers vested in me by law, do hereby place some portions of the affected barangays under Heightened Localized Enhanced Community Quarantine (critical zone) for at least three (3) calendar days starting today, April 3, 2021 at 7:00 PM.

Section 1. Coverage. This order covers the following portions of the hereunder barangays:

 - 1. Sector 3: 4 houses

 - 1. Sector 3: 1 compound (3 houses)
 - 2. Sector 6: 2 houses
 - 3. Sector 7: 1 compound (3 houses)

Section 2. GUIDELINES:

- **A.** Movement of the affected families is prohibited. All individuals in the abovementioned sector are directed to stay at home, except in following cases:
 - **1.** When availing necessary medical procedures that are not available in healthcare institutions within the municipality.
 - **2.** Emergency situations that would require immediate medical attention such as birthing, serious physical injuries, etc.
- **B.** A team shall be organized to take and turn over orders (medicines and other necessities) to the affected families during the duration of the lockdown.

Section 2. The importance of adhering to the established health standards set forth by the Department of Health (DOH) and LGU of Agoo is reiterated.

Section 3. Penalty. Any person or entity found to have violated sections of this Executive order shall be prosecuted and penalized in accordance with the provisions of Republic Act 11332.

Section 4. Repealing Clause. Previous issuance or any portion thereof, which are inconsistent with the provision of this Executive Order are hereby amended, modified, superseded or repealed accordingly.

Section 5. Separability Clause. If any section or provision of this Executive Order is declared void, ineffective or invalid by a court of competent jurisdiction, the holding of such section or provision to be void or invalid for any cause whatsoever shall in no way affect the validity of the remaining sections and provisions, which shall remain in full force and effect.

Section 6. Effectivity Clause. This Executive Order shall take effect immediately and shall remain in effect until rescinded, repealed or amended.
