RESOLUTION RECOMMENDING THE APPROVAL AND ADOPTION OF REPEAT ORDER AS AN ALTERNATIVE METHOD OF PROCUREMENT FOR THE PURCHASE OF RICE FOR USE OF THE OFFICE OF THE PROVINCIAL GOVERNOR.

WHEREAS, presented before this Body is the need to purchase Rice (345 cavans) for the use of the Office of the Provincial Governor to be distributed to the indigents of the province in the amount of Seven Hundred Three Thousand Eight Hundred Pesos (P703,800.00);

WHEREAS, under Section 51 of Rule XVI of the Revised Implementing Rules and Regulations (IRR) of RA 9184, the Procuring Entity may resort to Repeat Order as an alternative method of procurement, subject to approval of the Head of the Procuring Entity and whenever justified by the conditions provided in the aforementioned law;

WHEREAS, the said Section provides for the "procurement of Goods from the previous winning bidder, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding...", provided, that the terms and conditions for the use of the Alternative Methods of procurement found in Section 54 of the Revised IRR shall be followed, if applicable; and

WHEREAS, the Procuring Entity had previously awarded the Contract for the Supply and Delivery of Rice (1,380 cavans) to Metrovision Customized Printing & General Merchandise worth Two Million Eight Hundred Fifteen Thousand Two Hundred Pesos (P2,815,200.00) last July 19, 2021 to which the former paid the latter for the complete delivery thereof; and

WHEREAS, the Bids and Awards Committee (BAC), in order to promote economy and efficiency, recommended Repeat Order as an alternative method of procurement for the purchase of Rice amounting to P703,800.00;

WHEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby resolved to adopt Repeat Order as an alternative method of procurement pursuant to Section 51 of the Revised IRR;
