#### **CONTRACT OF AGREEMENT**

THIS AGREEMENT made on the 4th day of April 2022 between Provincial Government of La Union (PGLU), Provincial Capitol, Barangay II, City of San Fernando, La Union (hereinafter called "the Entity") and NQA Philippines Inc., Unit 1504B 15/F Richville Corporate Tower, 1107 Alabang-Zapote Road, Madrigal Business Park, Ayala Alabang, Muntinlupa City, Metro Manila, 1780 (hereinafter called "the Consultant").

WHEREAS the Entity execute the Engagement of Services of a Certifying Body to Conduct Audit and Provide ISO 9001:2015, ISO 14001:2015 and ISO 45001:2018 Integrated Management System Certification for the PGLU Five (5) District Hospitals and LUMC (hereinafter called "the Works") and the Entity has accepted a bid for Seven Hundred Thousand Pesos (₱700,000.00) by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Terms of Reference
  - (c) Request for Expression of Interest;
  - (d) Instructions to Bidders;
  - (e) Bid Data Sheet;
  - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (i) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
