### CONTRACT OF AGREEMENT

THIS AGREEMENT made on the **4<sup>th</sup> day of April 2022** between **Provincial Government of La Union (PGLU)**, Provincial Capitol, Barangay II, City of San Fernando, La Union (hereinafter called "the Entity") and **NQA Philippines Inc.**, Unit 1504B 15/F Richville Corporate Tower, 1107 Alabang-Zapote Road, Madrigal Business Park, Ayala Alabang, Muntinlupa City, Metro Manila, 1780 (hereinafter called "the Consultant").

WHEREAS the Entity execute the **Engagement of Services of a Certifying Body to Conduct Audit and Provide ISO 9001:2015, ISO 14001:2015 and ISO 45001:2018 Integrated Management System Certification for the PGLU Five (5) District Hospitals and LUMC** (hereinafter called "the Works") and the Entity has accepted a bid for **Seven Hundred Thousand Pesos (₱700,000.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

  - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
