BAC RESOLUTION DECLARING BALAI NORTE HOTELS AND RESORTS CORPORATION AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 17, 2022 the Request for Quotation for the Lease of Meeting Venue with Provision of Food and Room Accommodation with the Approved Budget for the Contract (ABC) of Two Hundred Seventy Thousand Six Hundred Twenty Pesos (P270,620.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;
