BAC RESOLUTION DECLARING SHIELD DRUGSTORE AND MEDIMARKETING CORPORATION AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on February 15, 2023 the Request for Quotation for the **Purchase of Medical, Dental and Laboratory Supplies** with the **Approved Budget for the Contract (ABC) of Eight Hundred Sixty-Three Thousand Six Hundred Sixty-Two Pesos and Fifty Centavos (P863,662.50)** in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;
