BAC RESOLUTION DECLARING GIOSETECH GENERAL MERCHANDISE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 5, 2022 the Request for Quotation for the **Purchase of Office Equipment** with the **Approved Budget for the Contract (ABC) of Nine Hundred Seventy Nine Thousand Five Hundred Pesos (P979,500.00)**, in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows;

- A. To declare **GIOSETECH GENERAL MERCHANDISE** as the winning supplier for the **Purchase of Office Equipment** for the use of the **Sangguniang Panlalawigan Office** under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.


