BAC Resolution No. DC-03-4-01 s. 2023

RESOLUTION RECOMMENDING THE APPROVAL AND ADOPTION OF DIRECT CONTRACTING OR SINGLE SOURCE PROCUREMENT AS AN ALTERNATIVE METHOD OF PROCUREMENT FOR THE PGS INSTITUTIONALIZATION OF THE PROVINCIAL GOVERNMENT OF LA UNION

whereas, presented before this Body is the need for the engagement of a service provider to provide planning workshops and facilitation services for the Performance Governance System (PGS) Institutionalization of the Provincial Government of La Union (PGLU) for use of the Provincial Planning and Development Office amounting to One Million Five Hundred Fifty Thousand Forty Pesos (₱1,550,040.00);

WHEREAS, the PGLU, in pursuit of good governance and performance in order to better its public services, previously adopted the Performance Governance System (PGS), the flagship program of the Institute for Solidarity in Asia (ISA), and engaged ISA's services to conduct the trainings, workshops and planning facilitation services needed for its governance reform programs;

WHEREAS, the PGS has four stages and the PGLU, in partnership with ISA, has already completed its PGS Initiation (focuses on strategy design), Compliance (focuses on strategy execution) and Proficiency (focuses on monitoring and evaluation of the strategy) Stages and is moving to complete its PGS Intitutionalization Stage (focuses on the attainment of breakthrough results and sustainability of the strategy);

WHEREAS, Section 50(a) of Rule XVI of the Revised Implementing Rules and Regulations (IRR) of RA 9184 provides for Direct Contracting or Single Source Procurement as an alternative mode of procurement that may be resorted to when "Procurement of Goods of proprietary nature which can be obtained only from the proprietary source, i.e. whent patents, trade secrets, and copyrights prohibit others from manufacturing the same item";

WHEREAS, the Bids and Awards Committee (BAC), in consideration of the reasons abovementioned, unanimously agreed that one of the conditions for Direct Contracting or Single Source Procurement as an alternative method of procurement is satisfied by the PGS Institutionalization of the PGLU amounting to ₱1,550,040.00;


WHEREAS, under Direct Contracting or Single Source Procurement, "the supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale" and "the offer may be accepted immediately or after some negotiations";
