WHEREAS, Section 53 of Rule XVI of the Revised Implementing Rules and Regulations (IRR) of RA 9184 provides for Negotiated Procurement as an alternative mode of procurement "whereby the procuring entity directly negotiates a contract with technically, legally and financially capable supplier, contractor or consultant...";

whereas, Section 53.6.1.e of the same IRR provides that the "Media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media" can be contracted to a particular supplier, contractor or consultant as determined by the Head of the Procuring Entity;

WHEREFORE, on motion duly seconded, be it

(Media Services) pursuant to Section 53.6.1 of the Revised IRR as an alternative method of procurement as a means for the Newspaper Subscription for the use of the Provincial Information Office under the Provincial Government of La Union amounting to P292,592.85;

RESOLVED FURTHER, to furnish a copy of this resolution to all persons and offices concerned for their information and guidance.
