WHEREAS, the Provincial Government of La Union (PGLU) advertised on May 13, 2023 the Request for Quotation for the **Purchase of Animal Feeds**, with the **Approved Budget for the Contract (ABC) of Two Hundred Forty Thousand Two Hundred Forty Pesos (P240,240.00)**, in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
