RESOLUTION RECOMMENDING THE APPROVAL AND ADOPTION OF NEGOTIATED PROCUREMENT (MEDIA SERVICES) AS AN ALTERNATIVE METHOD OF PROCUREMENT FOR THE PURCHASE OF MEDIA SERVICES FOR USE OF THE OFFICE OF THE SANGGUNIANG PANLALAWIGAN.

WHEREAS, presented before this Body is the need for the Purchase of Media Services for the use of the Office of the Sangguniang Panlalawigan in the amount of Sixty Thousand Pesos (P60,000.00);

WHEREAS, Section 53 of Rule XVI of the Revised Implementing Rules and Regulations (IRR) of RA 9184 provides for Negotiated Procurement as an alternative mode of procurement "whereby the procuring entity directly negotiates a contract with technically, legally and financially capable supplier, contractor or consultant...";

WHEREAS, Section 53.6.1.e of the same IRR provides that the "Media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media" can be contracted to a particular supplier, contractor or consultant as determined by the Head of the Procuring Entity;


WHEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby resolved to adopt Negotiated Procurement (Media Services) pursuant to Section 53.6.1 of the Revised IRR as an alternative method of procurement as a means for the Purchase of Media Services for the use of the Office of the Sangguniang Panlalawigan under the Provincial Government of La Union amounting to P60,000.00;

RESOLVED FURTHER, to furnish a copy of this resolution to all persons and offices concerned for their information and guidance.




