**BAC RESOLUTION DECLARING ZON RICE STORE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT**

**WHEREAS**, the Provincial Government of La Union (PGLU) advertised on May 13, 2023 the Request for Quotation for the **Purchase of Rice** with the **Approved Budget for the Contract (ABC) of Seven Hundred Sixty Five Thousand Pesos (P765,000.00)** in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;

**WHEREAS**, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

**WHEREAS**, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of **ZON RICE STORE** was found to be the Lowest Calculated Responsive Quotation (LCRQ).

**NOW THEREFORE**, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare **ZON RICE STORE** as the winning supplier for the **Purchase of Rice** for the use of the **Environment and Natural Resources Office** under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.






