WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 28, 2023 the Request for Quotation for the Purchase of Drugs and Medicines with the Approved Budget for the Contract (ABC) of Six Hundred Ninety Six Thousand Three Hundred Forty Pesos (P696,340.00) in the PGLU Website, Philgeps Website, BAC Bulletin Board at the Provincial Capital continuously for 1 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
