**BAC RESOLUTION DECLARING AGOO PRINTING PRESS AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT**

**WHEREAS**, the Provincial Government of La Union (PGLU) advertised on May 3, 2024 the Request for Quotation for the **Purchase of Streamers** with the **Approved Budget for the Contract (ABC)** of **One Hundred Twenty Thousand Pesos (P120,000.00)** in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 7 days;

**WHEREAS**, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

- To declare **AGOO PRINTING PRESS** as the winning supplier for the **Purchase of Streamers** for the use of the **PG-Environment and Natural Resources Office** under the Provincial Government of La Union; and
- To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.


