WHEREAS, the Provincial Government of La Union (PGLU) advertised on May 3, 2024 the Request for Quotation for the Purchase of Streamers with the Approved Budget for the Contract (ABC) of One Hundred Twenty Thousand Pesos (P120,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 7 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their auotations as follows:
