BAC RESOLUTION DECLARING GOLDEN LEAF NURSERY AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 19, 2023 the Request for Quotation for the **Purchase of Seedlings** with the **Approved Budget for the Contract (ABC)** of **Nine Hundred Fifty Thousand Pesos (P950,000.00)** in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
