WHEREAS, the Provincial Government of La Union (PGLU) advertised on September 20, 2024 the Request for Quotation for the Rental of Lights, Audio and Visual Equipment with the Approved Budget for the Contract (ABC) of Three Hundred Thousand Pesos (\$\mathbb{P}\$300,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously 3 days;
