BAC RESOLUTION DECLARING LEVATECH TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on June 22, 2024 the Request for Quotation for the **Purchase of Information Technology Parts and Accessories and Peripherals** with the **Approved Budget for the Contract (ABC) of Four Hundred Forty-Three Thousand Six Hundred Eighty-Six Pesos and Forty Centavos (P443,686.40)** in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;
