BAC RESOLUTION DECLARING AGOO PRINTING PRESS AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Unjon (PGLU) advertised on June 5, 2024 the Request for Quotation for the **Printing of Books** with the **Approved Budget** for the Contract (ABC) of Three Hundred Ten Thousand Six Hundred Thirty-Nine Pesos and Ninety-Eight Centavos (\$\mathbf{P}310,639.98) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 8 days;
