WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 11, 2024 the Request for Quotation for the Coaster and Bus Rental with the Approved Budget for the Contract (ABC) of Sixty-One Thousand Pesos (\$\P61,000.00)\) in the PGLU Website, PhilGEPS Website, and Bulletin Board at the Provincial Capitol continuously for 5 days;

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
