BAC RESOLUTION DECLARING LEVATECH TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on October 17, 2024 the Request for Quotation for the Purchase of Electrical Supplies with the Approved Budget for the Contract (ABC) of Sixty Thousand Pesos (₱60,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 4 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
