BAC RESOLUTION DECLARING WAVES POINT RESTO BAR AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on October 17, 2024 the Request for Quotation for the Lease of Venue with Provision of Food with the Approved Budget for the Contract (ABC) of One Hundred Thousand Pesos (₱100,000.00) in the BAC Bulletin Board at the Provincial Capitol continuously for 4 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of WAVES POINT RESTO BAR was found to be the Lowest Calculated Responsive Quotation (LCRQ).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare **WAVES POINT RESTO BAR** as the winning supplier for the **Lease** of Venue with Provision of Food for the use of the La Union Provincial Tourism Office under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
