BAC RESOLUTION DECLARING CROSS COUNTRY MOTORS INCORPORATED AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING **AWARD OF CONTRACT**

WHEREAS, the Provincial Government of La Union (PGLU) advertised on September 21, 2024 the Request for Quotation for the Repair and Maintenance of Bus with the Approved Budget for the Contract (ABC) of Fifty-Three Thousand Seven Hundred Sixty-Four Pesos (\$\mathbb{P}\$53,764.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 6 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
