#### BAC RESOLUTION DECLARING NAMIE NON-SPECIALIZED WHOLESALE TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on October 30, 2024 the Request for Quotation for the Purchase of Tokens with the Approved Budget for the Contract (ABC) of One Hundred Ninety-Two Thousand Pesos (₱192,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
