## BAC RESOLUTION DECLARING ZDESIGNS GARMENT FRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on September 20, 2024 the Request for Quotation for the Purchase of Training Kits with the Approved Budget for the Contract (ABC) of Sixty Thousand Pesos (₱60,000.00) in the PGLU Website, Philgeps Website, and Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

**NOW THEREFORE**, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare ZDESIGNS GARMENT TRADING as the winning supplier for the Purchase of Training Kits for the use of the La Union Provincial Tourism Office under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
