BAC RESOLUTION DECLARING HEMS DRY GOODS STORE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 30, 2024 the Request for Quotation for the **Purchase of Customized T-Shirt** with the **Approved Budget for the Contract (ABC)** of **One Hundred Forty-Four Thousand Pesos (₱144,000.00)** in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;
