BAC RESOLUTION DECLARING BRIGGS-KAITH TRAVEL AND TOURS AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on September 20, 2024 the Request for Quotation for the Provision of Van Rental with the Approved Budget for the Contract (ABC) of Sixty-Four Thousand Pesos (₱64,000.00) in the PGLU Website, PhilGEPS Website, and Bulletin Board at the Provincial Capitol continuously for 3 days;
