BAC RESOLUTION DECLARING A-RAMP TRADING AND YOUR EYE CARE CLINIC AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQs) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on August 30, 2024 the Request for Quotation for the Approved Budget for the Contract (ABC) of Six Hundred Sixty-One Thousand Nine Hundred Pesos (₱661,900.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVED**:

- A. To declare A-RAMP TRADING AND YOUR EYE CARE CLINIC as the winning supplier for the Purchase of Assistive Devices for the use of the Provincial Social Welfare and Development Office under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
