BAC RESOLUTION DECLARING ZDESIGNS GARMENT TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 29, 2024 the Request for Quotation for the Purchase of Assorted Commodities with the Approved Budget for the Contract (ABC) of One Hundred Seventy-Four Thousand Six Hundred Pesos (₱174,600.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
