WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 14, 2024 the Request for Quotation for the Purchase of Assorted Commodities with the Approved Budget for the Contract (ABC) of One Hundred Twenty Thousand Pesos (₱120,000.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 4 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
