WHEREAS, the Provincial Government of La Union (PGLU) advertised on October 9, 2024 the Request for Quotation for the Purchase of Booth Design with the Approved Budget for the Contract (ABC) of Three Hundred Thousand Pesos (P300,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
