BAC RESOLUTION DECLARING A-RAMP TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 29, 2024 the Request for Quotation for the Supply and Delivery of Bougainvillea Lights with the Approved Budget for the Contract (ABC) of Nine Hundred Ninety-Five Thousand Pesos (₱995,000.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of **A-RAMP TRADING** was found to be the Lowest Calculated Responsive Quotation (LCRQ).

**NOW THEREFORE**, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare A-RAMP TRADING as the winning supplier for the Supply and Delivery of Bougainvillea Lights for the use of the La Union Provincial Tourism Office under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
