BAC RESOLUTION DECLARING PRE-AN'S ENTERPRISES AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on October 18, 2024 the Request for Quotation for the Supply and Delivery of Drugs and Medicines with the Approved Budget for the Contract (ABC) of Four Hundred Thirty-Five Thousand Thirty-Nine Pesos (\$\mathbb{P}435,039.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, four (4) suppliers submitted their quotations as follows:


