BAC RESOLUTION DECLARING DWEP EVENTS ORGANIZING SERVICES AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 29, 2024 the Request for Quotation for the Event/Venue Set-Up with the Approved Budget for the Contract (ABC) of One Hundred Thousand Pesos. (₱100,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

- A. To declare **DWEP EVENTS ORGANIZING SERVICES** as the winning supplier for the Event/Venue Set-Up for the use of the Local Economic Enterprise and Investment Promotions Office under the Provincial Government of La Union; and
