WHEREAS, presented before this Body is the need for the procurement of consultancy services for the use of the Office of the Provincial Government – Environment and Natural Resources Office (PG-ENRO) under the Provincial Government of La Union (PGLU) specifically for the Engagement of Consultancy Services for the Development of Greenhouse Gas Emissions Inventory for the Province of La Union (Phase II) with an Approved Budget for the Contract (ABC) of Three Hundred Thousand Pesos (Php300,000.00).

WHEREAS, a Request for Proposal (RFP) indicating the Approved Budget for the Contract (ABC) with attached terms and conditions of the consultancy service to be procured, was posted on October 4, 2024 until October 15, 2024, in the Philippine Government Electronic Procurement System (PhilGEPS) website, PGLU Website, and at a conspicuous place reserved for this purpose in the Provincial Capitol Building;

WHEREAS, the BAC, through its Secretariat requested quotations from three (3) suppliers, namely, ICLEI-LOCAL GOVERNMENTS FOR SUSTAINABILITY SOUTHEAST ASIA INC., CLEAN AIR ASIA AND BV PHILIPPINES;

**WHEREAS**, in response to the said postings, only **ICLEI** submitted to the BAC its proposals and was opened on October 15, 2024 during the BAC meeting;

WHEREAS, ICLEI complied with the required documents pursuant to Section IX (General Conditions) under the Request for Proposal with results as follows:
