BAC RESOLUTION DECLARING EAGLENORTH MEDICAL TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCPQ) AND DECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on August 22, 2024 the Request for Quotation for the Purchase of Mechanical Hospital Bed with the Approved Budget for the Contract (ABC) of Ninety-Nine Thousand Pesos (₱99,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 7 days;

WHEREAS, in response to the said advertisement, four (4) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the four (4) suppliers, the quotation of EAGLENORTH MEDICAL TRADING was found to be the Lowest Calculated Responsive Quotation (LCRQ).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare EAGLENORTH MEDICAL TRADING as the winning supplier for the Purchase of Mechanical Hospital Bed for the use of the Provincial Social Welfare and Development Office under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.


