BAC RESOLUTION DECLARING BLAISE-SCIENTIFIC TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on July 2, 2024 the Request for Quotation for the Repair and Maintenance of Machinery Equipment with the Approved Budget for the Contract (ABC) of Seventy Thousand Pesos (\$\P70,000.00\$) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of BLAISE-SCIENTIFIC TRADING was found to be the Lowest Calculated Responsive Quotation (LCRQ).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare BLAISE-SCIENTIFIC TRADING as the winning supplier for the Repair and Maintenance of Machinery Equipment for the use of the PG-Environment and Natural Resources Office under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
