BAC RESOLUTION DECLARING GIOSETECH GENERAL MERCHANDISE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on September 27, 2024 the Request for Quotation for the Purchase of Office Supplies with the Approved Budget for the Contract (ABC) of Eighty-Seven Thousand Fourteen Pesos and Forty Centavos (\$\mathbb{P}87,0\text{14.40}\$) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
