## RESOLUTION NO. 223-AG s. 2024

## BAC RESOLUTION DECLARING SEVEN SEAGULL ENTERPRISES AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 13, 2024 the Request for Quotation for the Purchase of Plaques with the Approved Budget for the Contract (ABC) of One Hundred Twenty Thousand Pesos (₱120,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
