BAC RESOLUTION DECLARING ZDESIGNS GARMENT TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on September 20, 2024 the Request for Quotation for the Purchase of Customized Plagues with the Approved Budget for the Contract (ABC) of One Hundred Fifty Thousand Pesos (₱150,000.00) in the PGLU Website, Philgeps Website, and Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of **ZDESIGNS GARMENT TRADING** was found to be the Lowest Calculated Responsive Quotation (LCRQ).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
